## **Foreword**

#### Nunu Kidane

Executive Director, Priority Africa Network

This resource is provided as a guide for accessing critically needed legal information. It is relevant for all immigrants, but particularly focused on Black immigrants.

My connections to our community are deep and personal. Having many family members and friends in the Bay Area, I have a vested interest in the well-being of our diverse community of Black immigrants. I am also well aware that often such information is shared informally when needed. In such cases, the advice given may often not be factually reliable, and may even lead to unnecessary legal complications.

As Black foreigners we are distinct and must navigate our racial and immigration status with particular disadvantages. It is clear we are not "African-American" with a long presence and history of that particular identity. Neither are we seen as the typical "immigrant" and are often not included in the services or outreach by 'immigrant-serving' agencies.

This puts us in uncharted legal territory, since we are often seen as African Americans with all the associated assumptions and prejudices. Our cultural and language needs also place us in vulnerable positions, without the broad general protections afforded to African Americans. This directory is intended to address the social and legal realities and complexities of Black immigrants in the Bay Area.

For the past two decades, I have had the privilege of serving PAN, an organization that raises awareness of the growing diversity of Black people in the US. We have based this work on inclusion and recognition of the diversity of identities and lived experiences of people of African descent. The continued increase of people from Africa as well as the Caribbean is undoubtedly adding to the economic and cultural vitality of a changing Bay Area. That also means addressing the challenges that arise from the dual identities of being Black and immigrant, as well as, other identities as undocumented, women, LGBTQ, and other ways we express ourselves as individual people.

The work that has gone into producing this directory is based on the love and care for this diverse and complex community of Black people. It is based on the spiritual foundation of the South African tradition of Ubuntu (*I am, because you are*) that recognizes that our lives are interlinked and we share a common destiny.

This resource is available to all who may need it free of charge.

# The Immigration Legal Service-Providers Directory

This is a resource for all immigrants but was particularly developed to serve the needs of immigrants from Africa and the Caribbean. It has information that addresses the needs of vulnerable and invisible communities to access affordable and language-specific legal support for immigration matters.


Listings in this directory include not-for-profit agencies providing free services, as well as private attorneys and paralegals. We recognize the informal information-sharing system among close-knit immigrant communities is not always reliable, even when it comes with care from 'trusted' sources like family and friends. The directory is being provided free of charge by Priority Africa Network. We hope you share it widely with those you know who need it.

# **About Priority Africa Network (PAN)**

In 2023, PAN celebrates its twentieth anniversary! We are proud of a history that serves as a stable 'NorthStar' organization to the decades of US-Africa solidarity.

Our current programmatic focus continues in recognizing our growing population of Black immigrants in the Bay Area whose needs are not fully addressed. The handful of organizations serving them are the least resourced among immigration legal and service providers. PAN is a leading advocate for Black immigrants, the majority of whom are African. Over the past two decades, the Black immigrant population has increased steadily. But there are still few services that are strategically aligned to serve their needs for legal support on immigration.





# Introduction

One of the challenges immigrants face when settling in a new country is getting a proper understanding of the laws and conditions of their entry. To many, navigating the legal complexities of their status can seem daunting. Whether entering the US as refugees, asylees, on student or family visas, or undocumented, all immigrants are in need of clear guidelines to ensure they are abiding by the laws of the country. Not knowing the law is not an acceptable excuse for infractions and can have severe consequences for those who are uninformed. This is particularly true for Black immigrants who are criminalized and placed on a deportation track at higher rates than any other immigrants.

Caught in the nexus of racial profiling and unclear immigration status, many suffer the consequences of not knowing when and how to protect themselves and their families. Many who are undocumented are subject to deportation because they failed to address their legal needs in a timely manner. Nationally, an estimated 23% of immigrants are unauthorized, of which 14% (approximately 625,000) are Black immigrants.

While for the most part Black immigrants are virtually invisible, blending into existing African American communities, the undocumented are "hyper-visible," criminalized, detained and deported at disproportionate percentages. Many who have their proper papers desire to gain citizenship to secure their stay permanently. However, Black immigrants are also denied citizenship in disproportionate numbers. For example, "Blacks from Muslim-majority countries are much less likely to be approved than Whites from other countries." (PNAS Feb 2022)

In the past two decades, the African-born Black immigrant population rose from half a million to nearly 2 million; over 40% immigrated to the US in the last decade. Even as California's Black/African American population is in decline, those of foreign Blacks continue to grow. According to a 2018 BAJI report (also from USC), the majority of Black immigrants living in the Bay Area (60%) are from Africa 33% East African, 17% West African and 10% other Africans.. (footnote add on the baji report)

In recent years, an increasing number of undocumented immigrants are crossing the US-Mexican border. Black migrants from Sub-Saharan Africa crossing that border increased dramatically in recent years, from 200 in 2019 to 1,200 in 2020. The number is expected to exceed 1,800 by 2023. According to historical data published by the U.S. Customs and Border Protection, over 56,000 Haitians reached the U.S. in the fiscal year 2022. In 2021, over 45,000 people from Haiti were arrested at the border, an increase from under 4,400 in 2020. However, very few organizations and individuals provide legal support to Black immigrants at that border. For the most part, they remain invisible and their needs ignored because of their racial identities, both in Mexico and in the US.

This directory was created to inform communities that are virtually invisible to conventional immigration service providers. Very few, if any, African American legal institutions know about or provide immigration support to foreign Blacks.

Typical "immigrant" focused agencies are not aware of the growing population of immigrants and continue to define immigrants as being primarily Asian or Latinx. This directory has been compiled to speak to the particular needs of Black people in the US who are foreign and disenfranchised, to provide a verified and reliable list of legal service providers that can help them navigate the complex landscape of immigration laws and policies.

# Language and translation needs

One high priority is to ensure people who need the information can use it easily by including translated sections of the directory. In addition to non-profit agencies, this directory includes a list of private attorneys and paralegal support providers who speak languages from different African countries. The lack of affordable language services has been a major barrier for many who need legal services but may not speak English.

All standard documents of the US Customs & Immigration Service (USCIS) are available only in English. Without access to proper translation, most immigrants cannot fully comprehend the laws to understand their rights and obligations which can lead to complicating their status.

The law provides language assistance to immigrants based on the population size. For example, most agencies are mandated to provide interpretation in Spanish, Mandarin, or Cantonese because there are large populations that need these languages, especially in the Bay Area. This is not the case for Africans where many different languages are spoken by highly diverse immigrant populations. Over the past decade or more, the Bay Area has had a significant increase in populations from East Africa who speak Amharic and Tigrinya. At present, there are no legal mandates to provide interpretation support services in these languages.

Legal service agencies are not obligated and do not provide language services for many African communities, based on the assumption that they are not sufficient in number to justify such a requirement. Many contacts listed in this directory have been included to address these specific concerns to have translations from or into Arabic, Swahili, Amharic and Tigrinya.

Language access is critical for immigrants to understand their rights and obligations and follow the legal mandates. Some of the agencies listed in the directory, particularly the African Advocacy Network and the Black Alliance for Just Immigration provide seminars and know-your-right sessions targeted specifically towards Black immigrants. They also have walk-in services or appointments for legal support.

With few formal translation agencies providing languages for immigrants from Africa, many have little choice but to rely on informal channels through family members or friends which are often unreliable. A cursory search of Bay Area agencies proves very few listings for languages spoken by Africans other than Arabic and French. Languages such as Amharic, Tigrinya, Swahili, Lingala, Akan, Ga, Somali, and Wolof.

The vast majority of the agencies in this directory are non-profit legal service providers funded by Congress through the Legal Services Corporation Act. They thus have a congressional mandate to serve all low-income persons seeking legal redress who reside in the US regardless of citizenship and national origin. If you have sought service from a legal service agency and been turned down, please inform Priority Africa Network of your experience.

# Gender-specific legal/social needs of Black immigrants

In recognition of the particularities that arise at the intersection of gender and immigration status, the directory includes legal service providers that address the needs of immigrant women, such as victims of domestic and/or gender-based violence. Studies show that immigrant women are at a higher risk of becoming victims of domestic violence or abuse than non-immigrants. The intersectionality of immigration with social factors such as gender, race, class, and culture exacerbate the abuse immigrant women face, sometimes with little resource to find solutions. Their immigration status can create institutional, social, and legal barriers that limit access to resources and social support. Abusive spouses have used their partner's documentation status as a means of control, such as (K1 or K3 visas) entering the US through marriage or financé visa. With incomplete or distorted perception of options available to them, victims of domestic violence may not be aware of the legal resources available to protect them.

This directory includes agencies that provide services specific to gender-related cases through the Violence Against Women Act (VAWA), including options to stay in the US via self-petition or the U nonimmigrant status visa. The U visa has provisions for protection against mental and physical abuse, based on the Victims Against Trafficking Violence & Battered Immigrant Women's Protection program. Please seek counsel with an expert or a legal service provider for more details about this.

Violence is generally assumed to be committed against women because they are the gender identified as vulnerable to domestic violence overwhelmingly perpetrated by men. However, PAN's framework upholds broader views of gender, recognizing that anyone can be a victim of domestic violence. Legal protections apply to all, including those affected by same-gender partners.

# Methodology

In putting this directory together, we first consulted with partner organizations from around the Bay Area who have been working in this field for many years, as well as online searches. The result was a list of conventional non-profit organizations, the majority of whom served Latinx and Asian immigrants.

It became very clear that we needed to go beyond this initial list, to identify

a wider set of agencies and the extent of their services adapted to Black and immigrant identities. We reviewed each agency on the list, verifying their services and costs and adding that information to the listing to ensure easy navigation and access. We also solicited referrals and suggestions from trusted members of our community.

This directory is the first of its kind specifically produced to meet the needs of Black immigrants. We have made efforts to ensure the reliability and relevance of the contents. We do not claim to have produced an exhaustive or final product. This is rather a baseline document that can be expanded and corrections made. Agencies and clients should submit corrections, comments, or suggestions to PAN at info@priorityafrica.org.

# How to use the document

We have tried to make this document accessible and easy to use. The columns should be self-explanatory, starting with name and contact information. It is formatted in such a way as searches can be conducted using city/county categories to find agencies in the closest location to residents. The language category includes languages that are provided by the agency at their offices. For additional language needs, please call the agency directly and inquire.

The directory has a column indicating what to expect to pay for services. The majority of the service providers are standard non-profit agencies with low or no cost depending on what each case involves. Also included, however, are a few private attorneys and agencies recognized by the Department Of Justice (DOJ, which may charge higher fees. Some of them have pro-bono (free or complimentary) options for limited time periods such as 15 minutes or 30 minutes.

The Immigration Legal Services Providers Directory

The East Bay Refugee and Immigrant Forum (EBRIF) was established in 1978 as the East Bay Refugee Forum in response to a large influx of Southeast Asian refugees. We are a coalition of over 35 agencies, organizations, advocates and community leaders serving immigrants, refugees, asylees, Special Immigrant Visa holders and others permanently displaced from their home countries by persecution, violence, or war who now seek refuge in the San Francisco East Bay. The EBRIF includes resettlement organizations, community-based non-profit organizations, community-based groups, members of the refugee community, individual advocates, community leaders, and government agencies.

The San Francisco Asylum Office hosts virtual orientation for persons with asylum status. You have the right to programs and new benefits and resources as a newly granted asylee. Some of these benefits are limited and time sensitive, beginning on the date that you are granted asylum. This orientation focuses on California benefits and services. However, some information applies to persons with asylum status throughout the U.S.A.

# Abbreviations Found in the Directory of Legal Service

#### **B-1: Temporary Business Visa**

You may be eligible for a B-1 visa if you will be participating in business activities of a commercial or professional nature in the United States.

#### **B-2: Temporary TourismVisa**

This visa classification is for tourists on vacation and people coming for medical treatment, a social event, or participation in amateur contests for no pay.

### **CAM: Central American Minors Refugee and Parole Program**

The CAM refugee and parole program provides certain qualified children who are nationals of El Salvador, Guatemala, and Honduras, as well as certain family members of those children an opportunity to apply for refugee status and possible resettlement in the United States.

### **CAT: Convention Against Torture**

If you fear you may be subjected to torture if you return to your home country, you may be eligible for CAT. According to international and U.S. law, a person cannot be returned to a country where they are likely to face torture. The United Nations Convention against Torture and Other Cruel, Inhuman, or Degrading Treatment or Punishment, requires countries that sign-on, to condemn and prohibit torture.

#### **DACA: Deferred Action for Childhood Arrivals**

DACA gives young undocumented immigrants protection from deportation and a work permit. The program expires after two years, subject to renewal.

#### DAPA: Deferred Action for Parents of Americans and Lawful Permanent Residents

If you receive deferred action under DAPA, you may be able to stay in the United States temporarily without fear of deportation. In addition, you will be considered for employment authorization, which would allow you to work legally in the United States, for a three year period.

#### EB-5 Visa: Employment Based Immigration: Fifth Preference

Under this program, investors (and their spouses and unmarried children under 21) are eligible to apply for a Green Card (permanent residence) if they make the necessary investment in a commercial enterprise in the United States and plan to create or preserve 10 permanent full-time jobs for qualified U.S. workers.

#### **FOIA: Freedom of Information Act**

Under FOIA and the Privacy Act (PA), you can request your own immigration records, someone else's immigration records (if you have their written permission) and agency policies, data, communications, and other records.

# H1B: Specialty Occupations, DOD Cooperative Research and Development Project Workers, and Fashion Models

This nonimmigrant classification applies to people who wish to perform services in a specialty occupation, services of exceptional merit and ability relating to a Department of Defense (DOD) cooperative research and development project, or services as a fashion model of distinguished merit or ability.

### I-485: Application to Register Permanent Residence or Adjust Status

Is used by a person in the United States to apply for lawful permanent resident status.

### NACARA: Nicaraguan Adjustment and Central American Relief Act

If an alien is granted cancellation of removal under the NACARA program, they will obtain lawful permanent resident status in the United States. The law targets Nicaraguan, Salvadoran, Guatemalan, Cuban and countries of the former USSR.

### SIJ: Special Immigrant Juveniles

If you are in the United States and need the protection of a juvenile court because you have been abused, abandoned or neglected by a parent, you may be eligible for Special Immigrant Juvenile (SIJ) classification. If SIJ classification is granted, you may qualify for lawful permanent residency.

### **TPS: Temporary Protected Status**

The Secretary of Homeland Security may designate a foreign country for TPS due to conditions in the country that temporarily prevent the country's nationals from returning safely, or in certain circumstances, where the country is unable to handle the return of its nationals adequately. USCIS may grant TPS to eligible nationals of certain countries (or parts of countries), who are already in the United States. Eligible individuals without nationality who last resided in the designated country may also be granted TPS.

#### T Visa: T nonimmigrant status

T nonimmigrant status (T visa) is available to noncitizens who are or have been victims of a severe form of trafficking in persons and assist law enforcement in the detection, investigation, or prosecution of acts of trafficking.

#### U Visa: U nonimmigrant status

The U nonimmigrant status (U visa) is set aside for victims of certain crimes who have suffered mental or physical abuse and are helpful to law enforcement or government officials in the investigation or prosecution of criminal activity.

#### **VAWA: Violence Against Women Act**

Provides noncitizens who have been abused by their U.S. citizen or lawful permanent resident relative the ability to independently petition for themselves (self-petition) for immigrant classification without the abuser's knowledge, consent, or participation in the immigration process. This allows victims to seek both safety and independence from their abusers.
